### **JSE Remote Disaster Recovery (DR) Site Connectivity update including invitation to attend a workshop regards connectivity alternatives**

Further to Market Notice **A1424** issued 17 May 2011, and Market Notice **A1434A** issued 10 June 2011, where we stated JSE Clients (all Members and non-Members) are required to connect to the Remote DR Site in the event of the JSE failing over to this remote site, Clients are reminded of the following:

- all Clients that are existing JSE Clients (all Members and non-Members) as at **30 June 2011** have until **30 September 2011** to implement and fully test their connectivity options to the JSE so as to ensure that by no later than 1 October 2011 any JSE Client can connect to and operate with the Remote DR Site should the JSE fail over to the Remote DR Site; and
- with effect from 1 July 2011, all new JSE Clients (all Members and non-Members) must implement and fully test their connectivity options to the JSE so as to ensure that by no later than 1 July any JSE Client can connect to and operate with the Remote DR Site should the JSE fail over to the Remote DR Site.

Clients who have not already advised the JSE of their chosen method of connectivity are advised to inform the JSE of their chosen method of connectivity as soon as possible so that the JSE can manage the migration and scheduling effectively.

To further assist derivative market participants with the above requirement, **a workshop will be held** at the JSE discussing the various alternative options available to connect to the Nutron Primary as well as the recently introduced Disaster Recovery sites:
