### New Currency Future Can-do Contract (CAEZ) – Knock-In Barrier Option on USD/Rand (Up and In)

The following new Currency Future Can-do Contract (CAEZ) has been added with immediate effect and is available for trading today.

Insofar as any contractual provision set out below is inconsistent with the rules, directives, regulations and margin methodologies (“**Rules**”) of the JSE Limited (“**JSE**”) in respect of Interest Rate and Currency Derivatives Market, the Rules will prevail unless the JSE expressly permits the Parties to give effect to their contractual provisions.

<b>Settlement</b>	The option contracts related to the Currency Future Can-do Contract, if exercised, will settle by means of Cash Settlement, the Option Cash Settlement Amount to be paid in ZAR
<b>Mark-to-Market</b>	Explicit Daily The forward value of the arithmetic average of the traded underlying observed for a 5 minute period between 16:55 and 17:00 Johannesburg time.
<b>Exchange Fees</b>	Sliding Scale – See below
<b>Initial Margin</b>	ZAR 156.00 (as determined by the JSE on a monthly basis)
<b>Class Spread Margin</b>	ZAR 0.00
<b>V.S.R.</b>	2.5
<b>Trade Date</b>	The date the Currency Future Can-do Contract is concluded
<b>Business Day</b>	Any day on which banks are open for business in Johannesburg and currency prices are published by the JSE.
<b>Option Style</b>	Style of the option contracts related to the Currency Future Can-do Contract: European, meaning that the rights granted under the option contracts related to the Currency Future Can-do Contract are exercisable on the date and at the time mentioned in Expiration and Valuation Date.
<b>Initial Reference Level</b>	The currency exchange rate for the Currency Pair as agreed by the Long Party and the Short Party on the Trade Date, being the level of the Currency Pair from which any movement in such currency exchange rate (the minimum of which is the Minimum Price Movement) will be determined

<b>Short Party</b>	The holder of the short position in respect of the Currency Future Can-do Contract

<b>Strike Price</b>	ZAR 10.2000/ USD1.00
<b>Knock-In Price</b>	ZAR 10.7000 / USD1.00
<b>Knock-In Event</b>	<p>A Knock-In Event will only be deemed to have occurred in the event the JSE in accordance with its discretion determines that a foreign exchange transaction has occurred at any Knock-In Valuation Time during the Knock-In Determination Period for the purchase of a minimum notional amount of <b>USD1Million</b> against the payment of ZAR at a currency exchange rate for the Currency Pair (as published by the Exchange) equal to or <b>higher</b> than the Knock-In Price.</p> <p>Should a Knock-In Event not occur, this Currency Future Can-do Contract will terminate all related option contracts will be closed out on the JSE at zero value and initial margin will be returned to the Buyer and the Seller.</p>
<b>Knock-In Determination Period</b>	The period from (and including) the Trade Date to (and including) the Expiration and Valuation Date.
<b>Knock-In Valuation Time</b>	Any time during Knock-In Determination Days when the USD/ZAR currency is open for trading on and monitored on the Reuters D3 system
<b>PROCEDURE FOR EXERCISE</b>	
<b>Expiration and Valuation Date</b>	<p>16 October 2013</p> <p>10:00 (10:00 a.m.) New York time (i.e. <b>16:00 (4:00 p.m.)</b> Johannesburg time), being the date and time of expiration of the option contracts related to the Currency Future Can-do Contract</p>
<b>Reference Price</b>	The closing currency exchange rate for the Currency Pair observed by the JSE on the Expiration and Valuation Date.
<b>Automatic Exercise</b>	Applicable
<b>Cash Settlement</b>	Applicable. If the Strike Price Differential is greater than zero, the Short Party shall pay the Long Party the Option Cash Settlement Amount for the number of option contracts held at the Expiration and Valuation Date.
<b>Option Cash Settlement Amount</b>	An amount equal to the number of option contracts exercised on the Expiration and Valuation Date multiplied by the Strike Price Differential, multiplied by the Multiplier multiplied by 1000.
<b>Strike Price Differential</b>	<p>An amount equal to the greater of:</p> <p>a) the Reference Price minus Strike Price; and</p> <p>b) zero.</p>

**This Instrument can trade at a negative value.**

\*Note: If a difference between the traded value and the initial valuation value occurs at inception. The difference will be smoothed out over a 21 day period, through the variation margin flow. In the case of a trigger event within the initial 21 day period, the remaining difference will be paid in full T+1.
