Please note that this dress rehearsal will be mandatory for Software Providers, Own Solution Developers and Information Subscribers that did not participate in the 9 May 2020 dress rehearsal.

This dress rehearsal will enable connectivity and testing of the upgraded version in Production. IP addresses and connectivity setup will be as per Production. Please remember, comprehensive testing is highly recommended to ensure a successful implementation, across all applicable asset classes.

For those wishing to participate this weekend, please send your contact details to the JSE Client Service Centre on customersupport@jse.co.za. Participants are requested to provide the member firms and CompID's that will be used on the day.

Clients not participating must ensure that their production systems are **shut down** prior to the systems start-up (preferably the evening before the scheduled change), to ensure that they do not receive and process any test data.

Clients should note the following:

- Conformed software is not a mandatory requirement for this dress rehearsal
- This dress rehearsal will not include end-of-day activities
- User-created instruments can be created on the day and traded on, however deal management activities will not be available on these newly created user-created instruments.
- Deal management activities will be available for all other existing instruments and you are encouraged to test this functionality.
- The order book will be empty for the dress rehearsal.
- All reference data (instruments, closing prices, Trader IDs etc.) will be as per production at close of business on Friday, 29 May 2020.
