UPDATE ON SENS MARKET DATA PRODUCT CHANGES – NEW GO-LIVE ON MONDAY 15 JULY 2019

The JSE was unfortunately not able to implement the Financial Results type announcement publishing changes on Monday, 24 June 2019 due to unforeseen technical problems on the Saturday when the final round of production testing took place.

The JSE has done extensive root cause analysis, and as a result, **has needed to make a key change to the way that it will present the address to the PDF version of the Full Financial Results type announcement.** Instead of providing a short Bit.Ly type link, the JSE will provide the full address in the link that point to the PDF version. Refer to the supporting document “Change of Bit.Ly link format to Full address link format” for an example of the change. Updated supporting specifications documents have also been provided.

It is crucial that clients that intend to access the PDF format of the full version Financial Results type announcement cater for the change in the link.

The JSE successfully conducted an internal production test this past Saturday which has put the JSE in a position to announce the revised implementation date of **Saturday, 13 July 2019** for a go-live date of **Monday, 15 July.**

To assist both live and non-live SENS market data clients, we will provide (optional) testing opportunities on the Saturday as per the below details on page 2 of this hotline.

The JSE will communicate any changes to the schedule timings via email on the Saturday as well as the go/no-go decision. If you want to be participate in the testing or want to be notified about the go/no-go decision then inform us in writing via mdprojects@jse.co.za and provide contact details (especially email address and mobile numbers).

Live SENS data subscribers

- The JSE will disseminate a number of set of test stories via the production live SENS market data feed from 10h00am (SAST).
- Subscribers that elect to test on the day can connect to the live SENS feed before 10h00 to test the receipt and processing of the test stories.
- The JSE will not be repeating the stories so it is important that you systems are ready to receive and process the test set.
- The period for live SENS data subscribers will end at 12h00.
- **Subscribers must ensure that test stories do not flow to any consumers, either on the Saturday or the subsequent go-live Monday.**

End of Day SENS data subscribers

- The JSE will produce test versions of the two standard End of Day data files after 12h00pm (SAST).
- The two files will be made available in the standard production folder on IDP between 12h00pm and 13h00 pm (SAST).
- Clients that elect to test on the day can connect to the production IDP server using their standard routines to access and process the relevant test data file(s).
- **Subscribers must ensure that test stories do not flow to any consumers, either on the Saturday or the subsequent go-live Monday.**
