## CHANGE TO JSE END OF DAY SENS MARKET DATA PRODUCTS

The JSE has received representations from issuers of market announcements about the complexity and effort of providing certain market announcements related to Financial Results in both Text and PDF format. The JSE has also occasionally received complaints from end users regarding formatting challenges in the Text versions of these Financial Results market announcements.

The JSE has decided, after consultations with stakeholders and for the above reasons, to institute a number of product changes and is notifying End of Day SENS market data subscribers about the future changes via this notice.

Due to the extent of these changes, the JSE is providing a **three month notice period starting from Wednesday, 6 February 2019.**

### Summary of future changes:

1. The JSE will provide Financial Results type market announcements **in PDF format only.**
2. The JSE will **introduce a new summary version** of the full Financial Results type market announcement in text as well as PDF formats.
3. Data subscribers that are licensed for the text market announcements will have to cater to receive and process both the summary and full Financial Results markets announcements, but the summary version in text format and the full Financial Results market announcement version in PDF format.
4. Data subscribers that are licensed for the PDF market announcements will have to cater to receive both the summary and full Financial Results markets announcements in PDF format.
5. The market announcements that are affected by this change are as follows:
  - Audited Results
  - Interim results
  - Late publication of financial information
  - Preliminary Results
  - Quarterly results
  - Reviewed results
  - Unaudited results
