CHANGES TO SENS MARKET DATA PRODUCTS – UPDATE AS AT 17 APRIL 2019

In response to client requests for more development and testing time as well as to ensure no potential impact during the stabilisation period post the go-live of the ITaC project, the JSE has decided to postpone the implementation date of the Financial Results type changes to **Monday, 20 May 2019**.

As a reminder, the JSE is currently providing 10 test JSE market announcement (SENS stories) for the convenience of both Live and Non-Live SENS data subscribers. Details of the exact stories are covered later. The JSE will be extending the test data to also include some Namibia Stock Exchange (NSX) announcements as the NSX is also affected by these changes. Details of the NSX test stories and their availability will be provided in due course via a separate hotline.

For SENS data subscribers that connect directly to the JSE systems:

- Live SENS data subscribers can access the test data via the JSE Client Service Test (CTS) facility. Our Customer Support team (customersupport@jse.co.za) can assist with connecting to the CTS environment.
