Examinations are held in Johannesburg (Sandton), Durban and Cape Town in the mornings of the dates advised. The times and venues will be advised to registered candidates.

Registration and payment for the examinations opens from date hereof. Candidates will not be allowed access to the examination venues if they have not registered and paid four weeks before exam date. Unfortunately no late registrations will be entertained.
