The Board examinations for membership, 1st Semester, 2016 will be held as follows:

FINANCE	Monday - 06 June 2016
TAXATION	Monday - 13 June 2016
INVESTMENT ADVICE & PORTFOLIO MANAGEMENT	Monday - 20 June 2016
THE ACT, RULES & PROCEDURES: PARTS I & II	Monday - 27 June 2016

Examinations are held in Johannesburg (Sandton), Durban and Cape Town in the mornings of the dates advised. The times and venues will be advised to registered candidates.

Registration and payment for the examinations opens from date hereof. Candidates will not be allowed access to the examination venues if they have not registered and paid four weeks before exam date. Unfortunately no late registrations will be entertained.

Rules I lectures commence on Wednesday, 16th March 2016. Lectures will be held on Wednesdays (at 18:00 – Saxo Capital Markets - Sandton).

Rules II lectures commence on Tuesday, 5th April 2016. Lecture evenings [usually two evenings per week] will vary due to the lecturers' availability and may be held on Mondays / Tuesdays or Wednesdays (Lectures start at 17:30 and will be held at the University of Johannesburg – Auckland Park Campus)

Investment lectures commence on Tuesday, 22nd March 2016. Lecture notes will be sent to registered candidates and the Lecturer will confirm dates for a 3 day workshop for registered candidates. The Workshop will be held at Saxo Capital Markets – Sandton and will also be available via Dial-In.

Lecture classes will be offered as mentioned above provided there are sufficient candidates registered for attendance otherwise modules will proceed via Correspondence on the above stated dates.

Taxation course commences on Thursday, 24th March 2016.

Lectures will be held on Thursdays – (at 18.00, Saxo Capital Markets -Sandton) and / or Saturdays (Venue TBA).

Kindly note that the Taxation lectures will only be offered if there are sufficient candidates registered for attendance.

Finance lectures offered - Correspondence only. Notes will be distributed on Tuesdays, commencing 22nd March 2016. Kindly note that the Finance course will only be offered if there are sufficient candidates registered for correspondence.
