The Board examinations for membership, 2nd Semester, 2017 will be held as follows:

<b>TAXATION:</b>	Mon, 20 Nov 2017
<b>* * FINANCE:</b>	Mon, 27 Nov 2017
<b>THE ACT, RULES &amp; PROCEDURES: PARTS I &amp; II:</b>	Mon, 4 Dec 2017

Examinations are held in Johannesburg (Sandton), Durban and Cape Town in the mornings of the dates advised. The times and venues will be advised to registered candidates.

**Registration and payment** for the examinations opens from date hereof. Candidates will not be allowed access to the examination venues if they have not registered and paid four weeks before exam date. Unfortunately no late registrations will be entertained.

**1. Rules I.** Lecture evenings will vary due to the lecturers' availability [initially, for the first two weeks, there will be two lectures per week on Tuesday and Wednesday] and thereafter one per week to be held on Wednesdays or occasionally Tuesdays). **The first lecture will be held on Tuesday, 22nd August 2017.** Lectures start at 18h00 and will be held a venue to be advised to all registered candidates.

**2. Rules II lectures commence on Monday, 4th September 2017.** Lecture evenings will vary due to the lecturers' availability [initially, for the first two weeks, there will be two lectures per week on Monday & Tuesday] and thereafter one per week to be held on Mondays or occasionally Tuesdays. Lectures start at 18h00 and will be held a venue to be advised to all registered candidates

**3. Taxation course commences on Thursday, 31st August 2017.**

Lectures will be held on Thursdays or occasionally Saturday mornings. Lectures start at 18h00 on Thursdays and 08h00 on Saturday and will be held a venue to be advised to all registered candidates

**Physical Lectures or correspondence is offered. Kindly note that the Rules I, Rules II and Taxation lecture classes will only be offered if there are sufficient candidates registered for attendance at lectures. Otherwise modules will continue via Correspondence on the above stated dates, provided there are sufficient candidates registered.**

**4.\* Investment lectures commence on 31st August 2017.** Lecture notes will be sent to registered candidates and the Lecturer will confirm date/s for a workshop for registered candidates. The Workshop will be held at Saxo Capital Markets – Sandton and will also be available via Dial-In).

**5. \*\* Finance lectures offered - Correspondence only.** Notes will be distributed on **Tuesdays, commencing 29th August 2017. Kindly note that the Finance course will only be offered if there are sufficient candidates registered for correspondence.**
