BESA Integration – Market Dress Rehearsal 2 and Go Live of Software.

Dear Stakeholder

The JSE would like to thank all customers who participated in the BESA Integration Dress Rehearsal on 26 February 2011. We are pleased to announce that the test was a success. Issues brought to the attention of the JSE on the day will be addressed directly with the customers that raised them during the course of this week.

Dress Rehearsal 2 of the BESA Integration project will take place on 12 March 2011 – once again participation in this dress rehearsal is mandatory for all users of the Interest Rate Market. Information for this dress rehearsal will be communicated during the week of 07 March 2011.

The JSE has further decided to formally give notice that the upgraded software used during Dress Rehearsal 2 will remain live in production post the 12 March 2011 test. The impact to the various stakeholders is as follows for trading from 14 March 2011:

- All NUTRON front end users will need to connect with version 1.0.0.26377 (all previous versions of the front end will not be able to connect)
- API users need to ensure that their software is upgraded to work with the Currencies and Interest Rates API version 3 revision 15
- Clearing Members need to ensure that their download service is compatible with the BESA Integration version reference data downloads

The NUTRON front end version 1.0.0.26377 is available for download at www.yieldx.co.za/pub in the BESA_DR2_NUTRONFrontend folder. The click once version will be made available after the Dress Rehearsal on 12 March 2011.
