### Final Confirmation of the Interest Rate Market go-live on the NUTRON platform

Following sign-off by 39 of 43 members, the JSE considers the dress rehearsal held on Saturday, 07<sup>th</sup> May 2011 to be successful. Post a successful network connectivity test to Strate, the JSE is pleased to announce that the Nutron platform is planned to go live for the reporting of bond transactions on Monday 09<sup>th</sup> May. This decision remains subject to the trade connectivity test between Nutron and the Strate BMA system before business opens on Monday 9<sup>th</sup> May as per Market Notice Y651, Y651C and Y652A. This test cannot be performed before Monday as Strate cannot treat Saturday as a business day. **Should this not be successful the JSE will invoke the roll-back plan to re-connect BTB to Strate. Members must ensure they plan for this eventuality.**

In terms of the above, when Nutron is live the **BTB environment for report-only bonds will not be available from Monday, 09<sup>th</sup> May 2011**. Trading Members are also reminded that they can only start reporting trades from 08h30 on Monday, 09<sup>th</sup> May 2011.

Trading Members **must ensure that they are using the correct version of the Nutron Front-end (Ver. 1.0.0.26377 Release Date 18/04/2011. This must be checked before booking ANY TRANSACTIONS.**

Further updates in regard of the results of the Monday trade test will be sent to Trading Members during the course of Monday.

The JSE would like to thank all market participants for their support during this week's parallel run and again today, in ensuring the success of this project.

We acknowledge that there is specific functionality users have requested to be added in further phases of this project. The JSE has noted these and further enhancements will be delivered in future releases.
