BDA batch processing commenced Friday evening and was completed midday Saturday. All BDA dissemination files and reports were available by 14h00 Saturday afternoon.

Based on the checking the JSE has been able to complete post the BDA batch, all settlement transactions for the settlement period 26 to 29 September 2017 were processed in BDA.
