| Expiration Valuation Method | The NGN/USD spot rate benchmark as sourced from the appropriate vendor. |
| Contract Size | NGN 100,000 nominal |
| Quotations | In Rand per one Nigerian Naira to four decimals |
| Minimum Price Movement | 0.0001 (R10.00) |
| Settlement | Cash settled in ZAR |
| Initial Margin Requirements | As determined by JSE Portfolio Scanning Methodology |
| Mark-to-market | The NGN spot rate benchmark is sourced from the appropriate vendor and at the relevant fixing time. At 17h00 the NGN forward points will be recorded and interpolated for each relevant expiry. The forward points will then be added to the NGN spot rate benchmark. The resultant forward rate will be crossed for each expiry with the corresponding USD/ZAR expiry date. |
