Members notice is drawn to section 13 of the contract specifications of Individual Equity Futures and options, which states:

# 13. Corporate Events

The JSE reserves the right to adopt any procedure or to adjust any single stock future or option on a single stock future, in a manner it deems fit, to deal with any extraordinary corporate events that may occur from time to time in relation to a share that is the underlying instrument of the equity option and to notify position holders, derivatives members and any other interested parties, of such event and the procedure or adjustment adopted. Such events include, for example, mergers, take-overs, unbundlings, capitalization issues and rights issues.

The implication of this is that anybody trading in Single Stock futures or options on Single Stock futures in which the underlying stock is the subject of an extraordinary corporate event should be aware that the JSE may make adjustments to the Single Stock futures and options.

## Special Dividend and Cash Dividend going ex on the same day

Hargreaves Lansdown PLC (HLII) has declared a special dividend of GBP 8.3 per share (The special dividend will be converted to ZAR at the prevailing GBP/ZAR exchange rate at EOD on LDT) and a cash dividend of GBP 23.4 per share (The cash dividend will be converted to ZAR at the prevailing GBP/ZAR exchange rate at EOD on LDT). With regard to this corporate action, the following adjustments will be made to Hargreaves Lansdown PLC (HLII) positions on 26 September 2019 (Ex-Date). The adjustments will be made to the positions held as at close of business on 25 September 2019 (LDT).

### **FUTURES CONTRACTS**

The futures position will be increased by the following factor:

<u>Calculation of factor</u>:

Spot price / adjusted price

Where:

Spot price = the official closing price of the underlying share on 25 September 2019 (LDT) – 23.4 (Cash Dividend)

**Adjusted price** = Spot price -1.513804 (Special Dividend rate Converted to ZAR).

Example: If the official closing price of the underlying shares on 25 September 2019 (LDT) is 367.87, the following would apply:

Spot price = 367.87 - 0.234 = 367.63

Adjusted price = 367.63 - 1.513804

= 366.12

Futures factor = 367.63 / 366.12

= 1.00412433082

**I.e.** Current positions\*Factor (rounded to nearest whole contract) = the number of total contracts. Additional contracts will be created at an initial value of zero.
