# ITaC Agreements – cutoff dates

---



- **JSE Services Agreement (JSA)**
  - Signed JSA is required to access ***all production and test services*** including the End-To-End environment
  - JSA must be signed by Friday, 27 July 2018 which is prior to the start of Scripted End-To-End testing on Monday, 30 July 2018 whether participating in ETE or not
- **JSE Data Agreement (JDA)**
  - Signed JDA is required to access all market data (live, intra day or EOD)
  - JDA must be signed by Friday, 27 July 2018 for clients wishing to participate in Scripted End-To-End testing which starts on Monday, 30 July 2018
  - JDA must be signed by 31 August 2018 for all other clients not participating in ETE testing

# Status Update – JSE activities

---



- JSE internal activities mostly on track and activities that are running slightly behind are not critical path
- Concluded regression testing, performance testing and systems non-functional testing
- JSE ETE operational readiness testing is currently in progress
- Internal training to complete by end July 2018
- External conceptual training for clients to complete by end August 2018
- Preparations for 14 July Dress Rehearsal underway and on track
- Business readiness criteria assessment by JSE Internal Audit underway

# Status Update – ETE Testing Cycle 1

---



- **Trading Members**
  - Low activity and participation levels due to issues experienced with connectivity and processing multicast data, mostly due to clients and/or SIPs not making the necessary changes to bind to multicast groups and Trading GW connectivity as IPs are different
  - One SIP had to upgrade infrastructure
  - One SWP resolving issue with processing Market Data A & B feeds which is affecting quite a few trading members for market bids and offers

# Status Update – ETE Testing Cycle 1

---



- **Information Subscribers**
  - Live Market Data
    - 3 clients enabled for live market data access
    - Access to ETE environment via International Access Point enabled
  - Non-Live Market Data
    - NLMD Data file provision will start again on Monday, 16 July 2018
    - Enabling of new testing participants is still continuing
    - Data Subscribers that have not yet firmed up data record subscriptions should make use of the ETE testing phase to make final decisions



# Status Update – ETE Testing Cycle 1



- **Clearing Members**

- All outstanding scope delivered by CM's vendor except:
  - For one CM: 2 reports (delivery date 9 July) & financial system integration CR approved at last Steering committee (delivery date awaited from Vendor)
  - For all CMs: Socks change (delivery date end July 2018)
  - Additional development by Vendor as per agreed change requests approved at Market Steering Committee
- Issues on reports raised by Clearing Members
  - Clearing members will only provide reports to clients wef 16 July 2018
  - JSE has implemented more formal reporting on status of reports testing and each CM will be required to report weekly on success/failure of each report on agreed scope list
- Month End interest calculations
  - JSE will be issuing a consultation paper to the market
- Clearing Member data conversion, migration & take on
  - Approach being discussed

# Dress Rehearsal Guide and Checklist



- Traders to make use of the **New Trading business functional test guide** to execute the testing applicable to your firm
  - **Trading business functional test guides DO NOT need to be completed and returned to the JSE**
  - Business functional tests are aligned to the different business events of the day e.g. Opening Auction, Continuous trading etc.
  - Please note your assigned counterparties for the trade reporting component of the test (this should have been provided to you by your buddy)
  - REVISED FINAL version will be published later today and be available for download at:
    - <https://www.jse.co.za/services/itac#OtherDocumentation>
- **Revised Post-trade business functional test checklist** to help you execute the testing applicable to your firm
  - **Post-trade checklist must be completed and returned to the JSE**
  - Please use the same assigned counterparties referred to above for the post trade activities. If there are any functions that cannot be completed using the assigned counterparties, please contact your buddy.
- Members must **confirm what business functionality is not applicable** to their firm
  - Dress rehearsal results generated by the JSE will be derived based on transaction data in JSE systems
  - Business functionality **not applicable to your business** and as provided to the JSE for the May dress rehearsals test worksheets will be used by the JSE for July test results
    - If you did not previously provide these business exclusions, kindly send an email to your JSE buddy indicating the scenario(s) not applicable to your Firm
    - Your JSE buddy will update the May Dress Rehearsal Test Worksheet with functional exclusions

# Dress Rehearsal Preparations



- Please ensure you have appropriate business representatives on site including relevant traders
- **Pre dress rehearsal systems availability:**
  - **Thurs & Fri - 12-13 July**
    - JSE Trading, Real-Time Clearing (RTC) and IDP systems available to prove technical login, connectivity and configuration setup
    - Test your front-end login connectivity to your Shared Infrastructure Provider (SIP) before Saturday
  - **Instrument Reference Data**
    - Instruments that have open interest as at Friday 6 July 2018 will match production data
    - New instruments that are created in production for the week of 9-13 July 2018 will also be loaded in the dress rehearsal prep environment
      - *However, please note that these instruments will have different Universal IDs and ISIN numbers than they have in production due to dual capture process in production and prep environment*
    - **Wed, 11 July** – first set of daily client CSV files and Instrument Mapping spreadsheet available at ~ 22h00
    - **Thurs, 12 July** – Incremental CSV files and Instrument mapping spreadsheet available early on Friday morning
    - **Fri, 13 July** - Incremental CSV files and Instrument Mapping spreadsheet available at ~ 22h00

# Dress Rehearsal Preparations



- **Saturday, 14 July 2018 – PLEASE NOTE!**
  - **Please ensure realistic prices are used for all orders and trades** – will be monitored by JSE and price band breaches and volatility auctions are included in pass/fail measurements
  - Full functional and technical dress rehearsal testing including **full Clearing end of day run**
  - Password changes:
    - RTC: if users logged on Thursday/Friday and reset their password from the default then the changed passwords will remain for Saturday. If users only logon on Saturday then they will need to change their passwords from the default
    - Trading: any password changes done this week will need to be redone on Saturday morning
  - During the dress rehearsal – JSE will load a new Single Stock futures, a Single Stock Anyday and Single Stock Options:
    - Clients to confirm that they have received the new instruments, and that they can trade on them
    - Clients to create user created Options, Anyday futures and Delta Options on the new instrument
  - JSE will suspend an Equity Instrument and its linked Derivative Instruments
  - Participants to verify dress rehearsal opening positions against NUTRON closing positions which have been taken as at COB Thurs, 12 July 2018. Participants to take note of Dividend Neutral position take on approach when verifying these positions

# Measuring Success of Dress Rehearsals

---



- **Technical Pass / Fail criteria** will be the same as for 12 & 26 May 2018:
  - **Trading Members:**
    - Login to all Native Trading, Post-Trade and Drop Copy GWs
    - Own Order Book Download (OOBD)
    - Own Trade Book Download (OTBD)
  - **Live Market Data subscribers**
    - Receive multicast data and Login and recover missed messages via the Replay/Recovery Gateways
- **Business Pass / Fail criteria** will be the same as for 12 & 26 May 2018 except we added criteria for ensuring normal market behaviour e.g. volatility auctions and price band breaches
  - **Less than 5 volatility auctions/price band breaches invoked by the member firm overall**
