"No, all queries must be captured on the Colo 2.0 portal, which will trigger a request to coloport@jse.co.za Thereafter if any intervention is needed from the JSE support team, the JSE's service providers support team will manage this directly with the JSE on behalf of clients and thus there is only a single point of contact for clients."

Is that included in the offering or would each client need to arrange their own internet breakout(s) + cross connects into the firewall?	Internet connectivity is available in Phase 1. Clients can also leverage their existing connections into the JSE to facilitate connectivity into the Colo 2.0 solution.
26	Please provide details of phase 2 of this project?	The purpose of Phase 2 is to introduce network connectivity to a secondary site and JSE DR site as well as International connectivity.
27	Will this solution be replacing your connectivity via Telehouse in London?	No, this solution will not be replacing the JSE Pop at Telehouse in London.
